#### GENDER



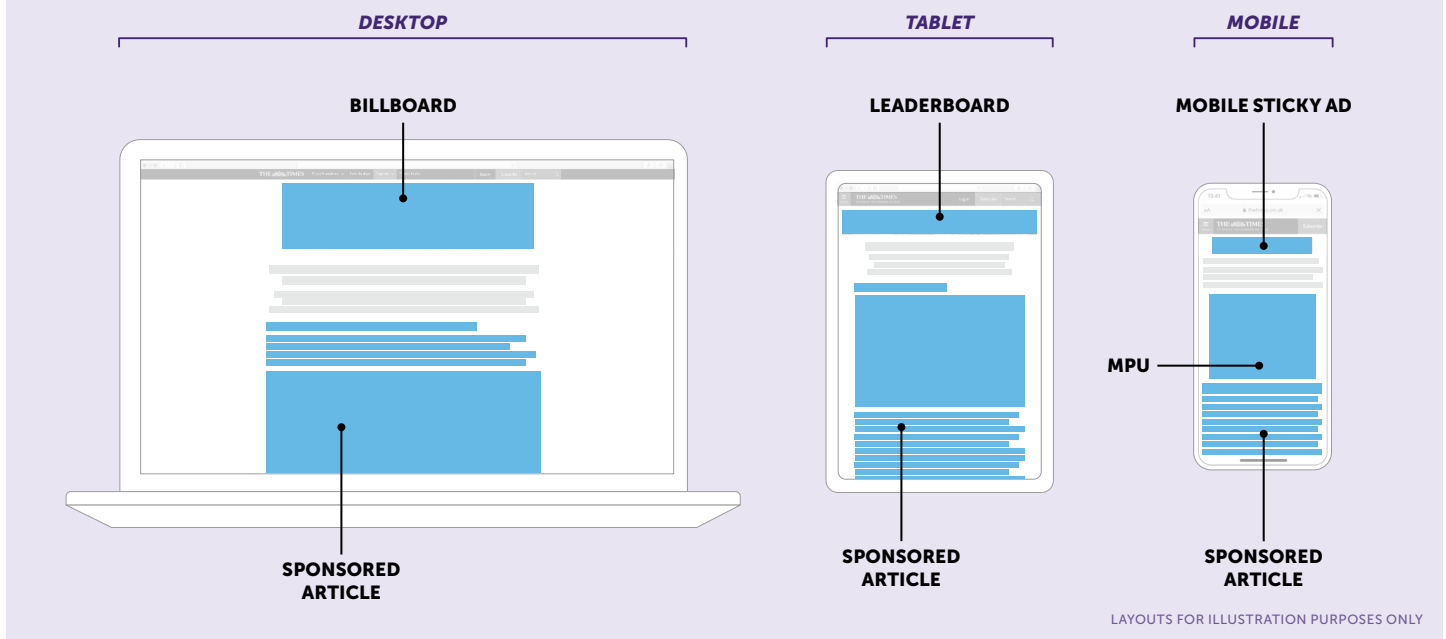
